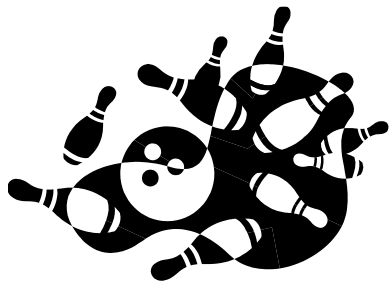


# 16<sup>th</sup> Annual Carnegie Center Bowling Tournament
