Home Run Hitting Contest

**500 Series Greenway
July 9, 10 and 12, 2019**

Official Rules

1. The Carnegie Center Wiffle Ball HR Hitting Contest is an individual competition.
2. All participants must be a current employee of a Carnegie Center tenant (that primarily works out of the Carnegie Center office), who is 18 years or older.
3. All participants are required to complete an application form and sign a waiver form. The application and waiver form is due to Julie Corrigan no later than 5:00 pm Tuesday, July 2, 2019.
4. Boston Properties will build a replica Fenway Park in the 500 Series Greenway.
5. Participants will attempt to hit as many HR's as possible during the competition.
6. Participants will be allowed 10 outs; an out occurs whenever a player swings at a pitch that doesn't result in a HR (i.e. swing and a miss, foul ball, a hit ball that doesn't go over the fence.)
7. Each participant must provide his or her own pitcher.
8. The preliminary rounds of the competition will occur between 11:30 - 1:30 pm (and possibly between 5:00 – 6:30 pm, if needed) on **July 9 & 10, 2019**
9. Participants will be notified when they are scheduled to compete in the Wiffle Ball HR Hitting Contest no later than 12:00 pm on **July 8, 2019**.
10. Participants (and their pitcher) must arrive to the 500 Series greenway at least 15 minutes prior to their scheduled time to check in with Boston Properties personnel.
11. Boston Properties will provide the official Wiffle Ball bats and balls that will be used during the competition; participants must use the Boston Properties equipment; they can not use their personal equipment.
12. The male and female participants totaling the top 5 HR totals from the preliminary round will be invited to the championship round on **July 12, 2019** to compete for the 1st, 2nd, and 3rd place trophies and prizes.
13. In addition, Boston Properties will award a team trophy and prize to the company that accrues the highest HR total from its top 4 participants, including at minimum 1 male and 1 female.
14. In the event of a tie during the championship round, those participants will compete again until the tie is broken.
15. The total number of participants may be limited.
16. Boston Properties judge rulings shall be final.
